## Minutes

#### Item 1

#### Welcome & Introductions:

- Richard Sails welcomed & thanked everyone for attending the meeting.

#### 3 Minutes of 2021 AGM ~ Approval & Matters Arising:

- Approval of the previous meeting's minutes was proposed and agreed.
- There were no matters arising or outstanding.

#### 4 Chairman's Report:

- Richard highlighted some of the events held during the past year. In particular, 2 Cadwell Track Days in addition to the usual one at Blyton Park. Others included Peaks to the Beach, Beamish Museum, Blackpool Pride, BSG, Pre'80s, London E-prix. Brooklands along with many more local events for which the ROs and deputies are responsible. During the year attendance at events have gradually increased despite some COVID 19 hangover.
- Richard expressed concern about the number of TVRs written off for relatively minor damage and urged members to have an agreed value and purchase a FireStick from the Club shop
- Finally, Richard made the point that our Club is not run by just the Committee or by the Office. The Club is actually run by the ROs, DROs and many other helpers, they are the Club and without them there wouldn't be a Club.

#### 5 Treasurer's Report:

- Paul explained that the Club is in a sound financial position. He then outlined the changes in our income and expenditure over the past 5 years. He also explained some of the cost increases he expected in the coming year.
- Events were normally run on a "break even" basis, but could apply for a subsidy in rare instances.
- As with many motor clubs membership has declined by about 10% and we are continuing to seek volunteers for critical roles.

#### 6 Presentation of Awards

#### **Trevor Wilkinson Trophy:**

Mervyn explained Trevor's Trophy was for the best restoration completed in 2021~22. There were 2 entries, both outstanding and included our newest ever entry. The voting was close, but the award this year belongs to Peter Richardson for his 1961 Grantura IIA which was featured in August's Sprint.

Edward Downer's 2002 Tamora will appear in a future Sprint.

#### Folkard Cup:

Richard explained this award was for the RO that has made the greatest contribution during the year. ROs and their Deputies are the backbone of our Club and work incredibly hard for their local members. There were several nominations, but the 2022 winner is Mark Cosh (Bristol).

#### Scott-Moncrieff Trophy:

Graham explained that for this year the TVR racing award goes to Matt Holben Matt has run an immaculate Tuscan challenge car, resplendent in Gulf colours for several years. More recently he's had a '60's Griffith built for historic racing. Even more impressively, has rebuilt the ex-Martin Short Tuscan R and campaigned it in Historic GT racing in Europe, culminating in this year's Le Mans Classic. When Jason Clegg's (Str8six) De Walt T400R broke down Matt then shared his car.
