3 Minutes of 2022 AGM ~ Approval & Matters Arising:

- Approval of the previous meeting's minutes was proposed and agreed.
- There were no matters arising or outstanding.

4 Chairman's Report:

- Richard explained that he would be standing down at the next AGM and also the reason that the 2024 AGM would take place at the end of March.
- Since the Covid 19 "lock down" the Committee has changed from bi-monthly meeting at the BMM Gaydon to monthly using zoom. Saving significant expense.
 Zoom has also enabled us to have sub-group meetings to work on particular topics and events. Eg. NEC Show, member recruitment.
- We've introduced our monthly eNews to highlight forthcoming events and any latest news. It goes to every member for whom we have an email address.
- We've increased the number of track days to 2 and considering a third for 2024. A survey was sent to existing and recent attendees.

8 Questions previously submitted to the Secretary

- Q. An RO on behalf of member had submitted a question about exemption from the London ULEZ.
- R. Mervyn explained that all cars registered in 2006 or later were Euro 4 compliant and exempt. Pre 2006 registered vehicles are assumed to be non-compliant and not exempt. Vehicles registered as DVLA Historic are also exempt, but TfL don't seem to register the DVLA status. His own 1979 3000S is not recognised as exempt. Mervyn will raise the issue at the forthcoming FBHVC AGM.
- **Q.** A member had submitted 3 factual questions. 1, a personal matter, 1 about anniversaries and the NEC Show, plus 1 about the change of the Club logo.
- R. Mervyn had already replied with the information.

9 Open Forum: "Questions from the Floor"

- Q. Should we offer a digital Sprint membership?
- R. Richard explained the question had been discussed previously on several occasions and the issue was regularly reviewed. At present the overwhelming majority of members wanted the retention of the hard copy. There will almost certainly come a time when Sprint goes digital, but the financial implications would also need to be considered.
 - This led to a lengthy discussion about the benefits/downsides of social media and keeping the Club relevant to both existing members while attracting new ones. Mark said the feedback from the recent membership questionnaire would guide future developments.
- Q. What was the outcome of the Track Day ballot?
- R. Richard, explained the questionnaire had been sent to those members who had attended a track day in recent years. Having run two days this year, if we were to offer a third in 2024 where should it be held? No decision has been made. Smaller circuits were perceived to be "safer" with less Armco?

Along with most of the World, we suffered a reduction in the value of our investments and thus there was a diminution in our Reserves







Membership Income

















Financial Accounts – Operational Results Investment Valuations (Decrease) / Increase





Conclusions & Plans

- Our income has improved marginally to meet inflationary costs
- Membership numbers are still down 8.9% in last 5 years but we're slowing the loss
- Costs are under control despite the cost-of-living increase that commenced in 2022
- There is a lack of volunteers in certain critical areas that causes us to engage consultants
- Direct debit increase helps to allow the Office to focus on our members requirements
- ☐ Making membership renewal by Direct Debit more financially attractive
- ☐ Increasing the membership fees incentive for DD to encourage this method of payment
- ☐ Continuing to focus on new & retention of members
- ☐ Continuing to seek volunteers for critical roles
- ☐ Increasing Events, inc. additional Track Day, ensuring events are not a drain on resources
- ☐ Continuing to closely monitor all our costs






