	agreed budget. Income is higher than budget, largely due to increased sales. But, both direct & indirect costs are over budget. Direct costs will suffer further	
	inflationary increases. The value of the club's investments is currently lower,	
	reflecting the general decrease in the Stock Market.	
	Membership numbers are again lower, Jane's analysis again points to members cutting costs or selling their car. She is achieving some success in	
	persuading renewals to continue. Mark proposed a small group to put forward	
	ideas to stem the decline and increase membership. Group to include Jane, a	
	ROCo and a couple of ROs. Hilton & Moss (ex. Castle TVR) would like a full-page prime position advert in	MT
