a. Nell Garner Open Day - Sat 30th March 2013

The event was well attended. It was agreed that the TVRCC only attend with a sales stand in 2014 if this fitted with other events and office requirements.

TVRCC Chatsworth Weekend – Sat 27th – Sun 28th April 2013

This was attended by 589 cars over the weekend. 60/70 people attended the dinner dance and around 60 cars took part in the Saturday run.

After many years, the current organiser (Kev) has decided not to organise this event in the future. The Committee recorded their thanks for his efforts in organising this event in the past. It was agreed that:

- The events team (AS and AP) and the office should organise the event in 2014.
- Tickets would be priced so that there was a differential between the price paid by members and non-members.
- Investigations should take place around the best way for the TVRCC to use the site in order that entrance fees go to TVRCC rather than Chatsworth.
